**PFS CERTIFIED INSPECTOR PROGRAM**

Clients/manufacturers listed in this chapter actively support the *PFS Certified Inspector Program*. PFS conducts technical seminars every six months and encourages its clients/manufacturers to participate in the voluntary PFS Certified Inspector Program. This program is conducted under the direct supervision of the vice president of quality control of PFS Corporation and is monitored by the PFS Quality Assurance Council, which is made up of safety and regulatory officials and consumer representatives.

By attending a certification seminar every year, the manufacturer's in-plant inspectors as well as PFS quality assurance inspectors are kept up-to-date in their field of expertise. The manufacturer's in-plant inspectors who participate in the seminar and pass the exam given at the end of the program are eligible to become *Certified PFS Inspectors* and receive a certificate recognizing their achievement. The hours listed after the certified PFS inspector's name represents the total formal classroom training hours attended by that inspector.
