FIRE TESTED PRODUCTS

Listing by Trademarking

Fire Tested Products are listed under a service designated as *Listing by Trademarking*. Construction assemblies (e.g., walls, floor-ceiling assemblies, etc.) are fire-rated in conformance with *ASTM E 119, Test Methods for Fire Tests of Building Construction and Materials*. Fire Doors are tested for conformance with *ASTM E 152, Standard Methods of Fire Tests of Door Assemblies*. Building materials are tested for surface burning characteristics in accordance with *ASTM E 84, Tests for Surface Burning Characteristics of Building Materials* or *NFPA 701-1977, Standard Methods of Fire Tests for Flame-Resistant Textiles and Films*.

The assembly, door or material rating or classification is shown on the PFS label. The PFS label on said product(s) is evidence that the fire doors have passed the above described tests and that the manufacturer is under contract for trademarking and follow-up inspection service.
